RESOLUTION ESTABLISHING ADMINISTRATIVE FEES FOR APPLICATIONS, PERMITS AND LICENCES, AND COSTS OF MUNICIPAL SERVICES

WHEREAS, in the opinion of Borough Council the current administrative fees & costs charged by the Borough of Coopersburg need to be updated routinely. These administrative fees include applications, permits & licenses, fines, & costs for municipal services;

NOW, THEREFORE, IT IS HEREBY RESOLVED that the following administrative fees & costs shall be set & charged by the Borough Of Coopersburg:

2. Zoning Permit Application Including all permits, decks, pools, accessory structures, & other zoning determinations	\$50.00
3. Appeal to Building Board Of Appeals/Zoning Hearing Board – Special Exceptions/Variances	\$750.00
4. Sign Permit (Unless additional Permits are needed – electrical & building)	\$50.00
5. Land Development & Subdivision (Plan Review) (Final Fee based on actual cost of review)	\$750.00
